The proposals should contain information detailing qualifications and ability from parties interested in providing an analysis of the current availability of broadband services in the County and formulating a plan outlining the design, construction, and operation of a broadband services network to unserved and underserved areas in Scott County. These proposals must be a detailed accounting of the respondent's history, capability, available resources, and proposed methodology to achieve the desired goal of designing and constructing a system capable of delivering high-speed broadband to all unserved and underserved areas within the county.

The county is considering short-term exclusivity with one partner but may extend future offers to other companies to foster competition.
