INVITATION TO BID

Scott County Fiscal Court will be accepting sealed proposals for mowing, landscape, and fertilization at the new fields located at Lisle Road Soccer Complex, Georgetown, Kentucky. Specifications can be viewed at scottky.gov/notes. The deadline is October 18, 2023 at 2:00 PM. Sealed, labeled proposals should be mailed or hand-delivered to the office of County Judge/Executive, 101 East Main Street #210, Georgetown, KY 40324. Scott County Fiscal Court has the right to reject any and all bids and waive informalities.

Service Specifications & Scope of Work

Primary Turf Area Mowing:

The primary areas to be mowed are indicated on the service area map. In the primary areas, mowing should occur no less than (28x) per season. Turf should be maintained to a height of approximately 2.5-4 inches, depending on the season and weather conditions. Special attention to be given to the playing surfaces so there is no excessive clumping of grass or thatch buildup. Complete site edging of all hard surfaces to establish a clean, crisp border between turf and hard edges. All edges around buildings, electrical poles, trees, curbs, etc. shall be trimmed to maintain the height of the turf. All hard surfaces, including any sidewalk, parking lot, pavilion area, etc. shall be blown off after each visit to ensure there is no accumulation of clippings, dirt, sand, leaves or other debris. All primary turf areas shall be kept free of sticks, rocks, trash & other debris.

Secondary Turf Area Mowing:

The secondary areas to be mowed are indicated on the service area map. In the secondary areas, mowing shall occur no less than (14x) per season. Trimming shall be implemented where trees and obstacles are present to accomplish a maintained look.

Landscape Bed Maintenance:

All landscape beds shall receive a fresh application of shredded hardwood mulch (brown) once a year in the spring. Mulch shall be a depth of 1.5-2 inches and should be uniform in depth and color. Prior to mulch application, existing vegetation shall be sprayed and removed. An application of pre-emergent herbicide shall be applied prior to mulch installation in the spring and then once again in the fall. Landscape bed areas shall be kept free of leaves, grass clippings and other debris and shall be policed for weeds on a bi-weekly basis during the growing season.

Vegetation Management:

All hard surfaces shall be policed for weeds and other vegetation on a bi-weekly basis for growth in cracks or other voids and removed by spraying or by hand pulling. A vegetation-free appearance shall be maintained.

Turf Fertilization:

Primary turf areas to be fertilized 1x in the early spring and 1x in the fall to promote grass vigor and optimum growth. Secondary turf areas to be fertilized 1x in the fall. Fertilizer products should contain a minimum of 50% time-released Nitrogen. A total of 3 lbs. of actual Nitrogen per 1000 square feet should be applied annually to primary turf areas. Other macro- and micro-nutrients applied should be tailored to recommendations based upon soil testing. All fertilization treatments are required to be documented in accordance with state laws. All hard surfaces shall be blown after fertilization to remove granular fertilizer.

Turf Treatment:

Primary turf areas to be treated for broadleaf weeds, sedge, and other non-desirable grasses 2x in the spring, 2x in the summer and 1x in the fall to maintain a weed free, healthy appearance. Pre-emergent

herbicide treatment shall be part of the spring treatment to prevent the germination of undesirable grasses and weeds.

Secondary turf areas to be treated for broadleaf weeds 1x in the spring and 1x in the fall to keep invasive weeds to a minimum. All products used should be labeled for use on athletic fields in the state of Kentucky. Safety Data Sheets for all products used will be made available to requiring personnel. Notification of treatment scheduling shall be coordinated with appropriate personnel, and the treated areas shall be flagged with dates and times of treatments. All pesticide treatments are required to be documented in accordance with state laws.
